Lure Coursing tests and trials shall be open to eligible breeds one year of age or older. For a complete listing of the breeds eligible to participate in the AKC Lure Coursing program, please visit the AKC website at:

http://www.akc.org/events/lure\_coursing/eligible\_breeds.cfm. Note: Portuguese Podengo Pequenos are not eligible to compete for Best In Field. Eligible dogs must be either individually registered with AKC, recorded with the Foundation Stock Service (FSS), individually registered with a foreign or domestic registry organization whose pedigrees are acceptable for AKC registration, or that have been granted a Purebred Alternative Listing (PAL/ILP). Hounds may not be entered as "registration pending" or "PAL/ILP pending" 5 whose pedigrees are acceptable for AKC registration.

A dog with an AKC Limited Registration or Conditional Registration shall be eligible to be entered in Lure Coursing tests and trials, as are spayed and neutered hounds. Monorchid and cryptorchid hounds are ineligible to participate. FSS breeds may earn suffix titles only

A dog that is individually registered with a foreign or domestic registry organization whose pedigrees are acceptable for AKC registration may be entered in licensed or member field trials that are held no later than 30 days after the date of the first licensed or member field trial in which the dog was entered, but only provided that the individual foreign registration number and the name of the country of birth are shown on the entry form, and provided further that the same name, which in the case of an imported dog must be the name on the foreign registration, is used for the dog each time.

An individually registered dog with a foreign or domestic registry organization whose pedigrees are acceptable for AKC registration may be entered in licensed or member trials that are held not later than 30 days after the date of the first licensed or member trial in which the dog was entered, unless the owner has received from the AKC an extension notice authorizing further entries of the hound with its foreign registration number. No such extension will be granted unless the owner can clearly demonstrate, in a letter addressed to the Performance Events Department of The AKC, that the delay in registration is due to circumstances for which he is not responsible. Such extension notice will be void upon registration of the dog or upon expiration of the period for which the extension has been granted if that occurs earlier, but upon application further extensions may be granted

Those sighthound breeds enrolled in AKC's FSS program which have been approved by the AKC Board to participate in Lure Coursing events are eligible to compete in Lure Coursing Tests and Trials. FSS breeds may earn the titles of Junior Courser, Senior Courser and Master Courser and may be certified as a Qualified Courser. SECTION 4. BREED DISQUALIFICATIONS. Hounds with breed disqualifications, as listed in the AKC Breed Standards, are ineligible to enter lure coursing trials and tests.

Stakes offered:

. JUNIOR COURSER and QUALIFIED COURSER TESTS. These tests are open to hounds at least 12 months of age. The course is a minimum of 600 yards with a minimum of four (4) turns.

OPEN STAKE. Open to all hounds that have obtained an AKC Qualified Courser certificate or an ASFA Certification Course certificate. This requirement will be waived for hounds that have earned a Field Championship title from the American Sighthound Field Association (ASFA) or the Canadian Kennel Club (CKC). ASFA or CKC Field Champions must submit a copy of their title certificate to the host club when they enter their first AKC Open Stake. This copy must be included when the results of the trial are sent to the AKC. Championship points earned from the Open Stake will only count toward a Field Champion title. Hounds that have earned an AKC Field Championship title of record are not eligible to enter the Open Stake

SPECIALS STAKE. Open to all hounds that have earned their AKC Field Championship titles. Championship points earned from the Specials Stake will count toward Lure Courser Excellent titles. Qualifying scores earned from the Specials Stake will count toward a Senior Courser or Master Courser title

VETERAN STAKE. Is offered at the option of the host club. Open to all hounds which are eligible to enter Open or Special stakes and meet the age requirement for a veteran as established by the breed's parent club -6 years of age; except Irish Wolfhounds =5 years, Whippets =7 years, Rhodesian Ridgebacks =7 years, Salukis =7 years, and Afghan Hounds =7 years. Championship points will be awarded. Points won 23 24 from the Veteran Stake may count toward either a Field Championship title or Lure Courser Excellent title.

SINGLES STAKE. A Singles Stake may be offered at a lure coursing trial at the option of the host club. If a Singles Stake is offered, it must appear in the event premium list. No points or passes counting toward AKC titles shall be awarded. All regulations pertaining to regular stakes shall apply unless modified by the regulations specific to this stake. Singles

## COVID:

Stay aware of the latest information on the COVID-19 outbreak, available on the WHO website and through your national and local public health authority. Most countries around the world have seen cases of COVID-19 and many are experiencing outbreaks. Authorities in China and some other countries have succeeded in slowing their outbreaks. However, the situation is unpredictable so check regularly for the latest news.

You can reduce your chances of being infected or spreading COVID-19 by taking some simple precautions:

- Regularly and thoroughly clean your hands with an alcoholbased hand rub or wash them with soap and water. Why?
   Washing your hands with soap and water or using alcoholbased hand rub kills viruses that may be on your hands.
- Maintain at least 1 metre (3 feet) distance between yourself and others. Why? When someone coughs, sneezes, or speaks they spray small liquid droplets from their nose or mouth which may contain virus. If you are too close, you can breathe in the droplets, including the COVID-19 virus if the person has the disease.
- Avoid going to crowded places. Why? Where people come together in crowds, you are more likely to come into close contact with someone that has COVID-19 and it is more difficult to maintain physical distance of 1 metre (3 feet).
- Avoid touching eyes, nose and mouth. Why? Hands touch many surfaces and can pick up viruses. Once contaminated, hands can transfer the virus to your eyes, nose or mouth. From there, the virus can enter your body and infect you.
- Make sure you, and the people around you, follow good respiratory hygiene. This means covering your mouth and nose with your bent elbow or tissue when you cough or sneeze. Then dispose of the used tissue immediately and wash your hands. Why? Droplets spread virus. By following good respiratory hygiene, you protect the people around you from viruses such as cold, flu and COVID-19.
- Stay home and self-isolate even with minor symptoms such as cough, headache, mild fever, until you recover. Have someone bring you supplies. If you need to leave your house, wear a mask to avoid infecting others. Why?

- Avoiding contact with others will protect them from possible COVID-19 and other viruses.
- If you have a fever, cough and difficulty breathing, seek
  medical attention, but call by telephone in advance if
  possible and follow the directions of your local health
  authority. Why? National and local authorities will have the
  most up to date information on the situation in your area.
  Calling in advance will allow your health care provider to
  quickly direct you to the right health facility. This will also
  protect you and help prevent spread of viruses and other
  infections.
- Keep up to date on the latest information from trusted sources, such as WHO or your local and national health authorities. Why? Local and national authorities are best placed to advise on what people in your area should be doing to protect themselves.

FROM THE EAST or NORTHEAST: New York State Thruway (I-90) to Exit 29 (mm 194 – Canajoharie,

Sharon Springs, Fort Plain, Cooperstown, Oneonta, St. Johnsville). Pay the toll – the big white Beech

Nut Foods factory will be on your right, a Betty Beaver's Getty station & small convenience store is

on the left. Turn RIGHT at the stop sign onto State Route (SR) 5-S West. Go thru the little traffic

light in Canajoharie, and continue on SR 5-S West for about 3 miles to the village of Fort Plain.

Drive across a small steel bridge over the canal -- turn LEFT at the light onto SR 80 South. Turn

RIGHT to Stewart's gas station/convenience store if you need fuel, or to pick up ice or snacks or

use the restroom – there is nothing between Fort Plain and the house. Watch the speed limits, &

make sure your seat belts are fastened; heavy fines up here. Stay on SR 80 South for about 9

miles – then watch for a 'Speed Zone Ahead' sign (35 mph) and a small painted sign Village of

Starkville. Please slow down (watch for cats, dogs, kids, tractors & Amish buggies). Elwood Road

### MORE ON COVID

:

1. Clubs, officials and participants are required to follow state and local guidelines that apply to the area where the event is held. 2. Practice social distancing consistent with current guidelines. Avoid congregating to the extent possible. 3. Consider wearing masks when in close proximity to others. Clubs should provide masks if desired for officials, judges and volunteers. 4. Consider wearing disposable or washable gloves. 5. Have plenty of hand sanitizers placed for people to use. 6. Wash hands as frequently as possible. Have disinfecting spray at bathroom facilities for people to spray door handles (or anything else they touch). 7. If you utilize portable toilets, please ask for a hand washing station to be delivered as well. 8. Avoid shaking hands or hugging. 9. Avoid touching dogs that are not your responsibility. 10. Avoid common use pens/pencils – bring your own. 11. Disinfect surfaces in common use areas as often as possible (tables, chairs, doorknobs, etc.) 12. Meals – Avoid or stagger group lunches/diners if possible. It is recommended that clubs supply boxed lunches for judges and volunteers. Hospitality areas should avoid communityitems such as salt and pepper shakers, condiments, creamers,

etc. Participants should consider bringing their own lunch/drinks. 13. Parking areas – Park with sufficient distance between vehicles if possible.

Event Practices 1. Lure Operators and Field Committee maintaining equipment should consider wearing facial coverings and gloves. 2. Safe handling of paperwork and payment for day-of-event entries. • Cash for day-of-event entries – inform participants they should have correct change. • Individual handling paperwork and entry fees should wear gloves. 3. Roll call and inspection committee functions can be performed in the parking area one dog at a time. All members of such field committees should consider wearing facial coverings and gloves. • Owners of females swipe their own dogs and show the inspection committee the tissue. • Wicket measuring can be done in the parking area. Other participants should avoid gathering around during the wicketing process. • Wickets should be wiped down between dogs. 4. Ask participants to wait by their vehicles until immediately prior to their running time. • Use a bull horn or PA system to inform participants when they should prepare to run. • Possibly use Remind (free app) to inform participants they should prepare to run. 5. Starting line – Consider having dogs start a minimum of 6 feet apart. Ask handlers to wear facial coverings when releasing their hounds. 6. The lures should be attached to the line at least 6 feet apart in order to reduce congestion at pickup. 7. If you are a catcher or releaser, consider using gloves and facial coverings when handling dogs and leashes. 8. Hunt Master should wear mask and gloves and to the extent feasible, be a minimum of 6 feet from handlers and dogs. 9. Trial Secretary should wear gloves to handle paperwork. 10. Consider having someone wearing gloves handing out ribbons or rosettes. No self-serve boxes. 11. Have a separate table at least 6 feet from trial secretary table for day of event entries, ribbon distribution and questions.

Policies that Have Been Temporarily Suspended 1. Event Application Late Fees – Event application late fees are waived through the end of October. This provide clubs more flexibility in planning or rescheduling their events. 2. For events cancelled in 2020, AKC will apply Event Application fees to the club's next event of the same type. Participants are expected to follow state, local government, facility and event guidelines. Clubs should be prepared to enforce the guidelines that apply to their event.
